

Newington Board of Selectmen's Minutes

Chr. Jan Stuart called the meeting to order at 7:05pm.

Present: Chairman Jan Stuart, Selectmen Cosmas Iocovozzi and Jack O'Reilly, Peg Lamson as Newington's Rep from the PDA, and Administrative Assistant Beatrice Marconi.

Appreciation Plaque for Hosting Boy Scouts of America

Ms. Lamson thanked Selectman O'Reilly for his time spent on the organizational meetings and also thanked the Selectmen for their kindness in hosting the Boy Scouts the weekend of the Air Show. Selectman O'Reilly moved to appointment Christopher Bellmare as a Trustee of the Trust Funds. Seconded Selectman Iocovozzi. Chr. Stuart added that she felt Mr. Bellmare would be a terrific asset to the position. Motion passed 3-0.

Election Worker Compensation

Because of the extended hours and State counting mandates placed on our workers, the Board felt the election workers should be paid more than the usual \$75.00. Therefore, ***Selectman Iocovozzi moved to pay the workers \$ 125.00 for Federal and State Elections and \$ 75.00 for all other Elections. Seconded by O'Reilly. Motion passed 3-0.***
