Water line	The new water line from Portsmouth has been installed to create a "loop" and improve water pressure in the historic district. 	However, engineering specs determined that this was not necessary. We are still pending the final cost from the water department. Rick Stern is working on obtaining those figures. Discussed the issue concerning the domestic water line that connects the cemetery, Meeting House, and the Library. It was discovered that the lines are tied in together so that there is no way to determine/track issues. We previously met with the Selectmen to see if they would agree to separating the lines so that the library was separate from other town buildings (allowing for better monitoring and budgeting). They felt that the cost to change the lines and add a meter would be excessive and there are not currently Town funds to pay for this. Marty and Jeff suggested that we consider separating the lines on our side of the lot and adding a meter specifically for the Library (the former meter would remain with the cemetery and MH at no cost for the Town). Economically, it makes sense to make this change now, during construction. Motion by Steve, seconded by Lee to add a domestic water line to the Library with its own water meter, paid for within the GMP (contingency, if needed).
