Road Agent Leonard Thomas spoke to the Selectmen about the results of the salt treatment used during the last snow storm. Selectman O'Reilly explained the process of chemically coating the salt and the non-corrosiveness of that treated salt. Road Agent Thomas said that during the last snow storm the Highway Department "pretreated" the roads with Salt that had been sprayed with Magic-O. Chairman Stuart asked if it made a difference at what temperature the salt was applied. Road Agent Thomas said no, it just needed to be applied before the roads were coated with snow. Selectman Iocovozzi stated that it would take care of two inches of snow without plowing. This treatment neutralizes the salt and doesn't corrode the road or equipment. Selectman Iocovozzi said that the Conservation Commission needs to meet with the representative from NH Ice Melt to answer their questions. Road Agent Thomas said that the treatment would not be needed in March because of the warmer temperatures. Chairman Stuart said she is impressed with the results that she had observed after the last storm. Road Agent Thomas requested a list from AA Gillespie of how many loads of salt were used this year. There was further discussion on upcoming snow storms.

A memo to the departments, committees and commissions from the Selectmen regarding budget spending was reviewed and will be signed upon corrections being made.

Selectman O'Reilly made the motion to accept the minutes of February 16th and 22nd. Seconded by Selectman Iocovozzi. Vote 3-0.
