Board of Selectmen Meeting Minutes Monday, January 6, 2014 Town Hall 6:30pm

Co-Chair Jan Stuart called the meeting to order at 6:30pm.

<u>Present:</u> Selectman Jan Stuart and Selectman Cosmas Iocovozzi. Also present was Martha Roy, Town Administrator.

Minutes Approval: C. Iocovozzi moved to approve the minutes of December 2 and 16, 2013. J. Stuart seconded this with all in favor.

Manifest Approval: C. Iocovozzi moved to approve Manifests dated 12/17/13 for \$31,831.37, 12/24/13 for \$43,307.01, 12/31/13 for \$56,448.11 and 1/7/14 for \$237,076.18. J. Stuart seconded this and all were in favor.

<u>Habitat for Humanity/ReStore:</u> C. Iocovozzi read the contract appraiser's letter to the Board stating that ReStore does not qualify for an exemption.

Chairman Rick Stern entered the meeting at this time.

Tom Hourihan, representing ReStore, stated that they wanted the matter reviewed with regard to Article V. It was agreed that Tom will meet with the Town's appraiser and discuss the matter.

Emergency Management: Generator maintenance was discussed. **C. Iocovozzi moved to approve an Emergency Management budget of \$15,338. J Stuart seconded the motion and all were in favor.**

<u>Fair Point communications Licensing of pole-Shattuck Way</u> – The Board discussed the pole installation. C. <u>Iocovozzi approved the Fairpoint Pole License request for installation on Shattuck Way</u>. J. Stuart seconded this and all were in favor.

Gate Clicker Request: Michael Giustino had requested a gate clicker. J. Stuart moved to approve the clicker for M Giustino, seconded by C. Iocovozzi with all in favor.

<u>Buffalo Wild Wings Coin Operated Game Machine Permit:</u> J. Stuart moved to approve the Coin Operated Game permit for Buffalo Wild Wings., seconded by C. Iocovozzi and all were in favor.

<u>Facilities Use Permit Requests</u>: C. Iocovozzi moved that the following events be approved by the Board:
