- Siding type
- o Windows, pattern of windows, size, spacing, proportion of wall, symmetry, shutters
- o Doors and entrances, sidelights, transom windows
- Architectural details, e.g., eave brackets, door facades, corner pilasters, porches,
- o Wells, cisterns, stone walls, fences
- o Foundation type
- o Foundation elevation
- o Chimneys
- Significant trees and landscape elements
