Board of Selectmen Meeting Minutes  
Wednesday, January 28, 2015 Town Hall 6:00pm

Chair Jan Stuart called the meeting to order at 6:02 pm

**Present:** Chair Jan Stuart, Selectman Cosmos Iocovozzi and Martha Roy, Town Administrator.

**Minutes Approval:** C. Iocovozzi moved to approve the public minutes of December 29<sup>th</sup>, January 5<sup>th</sup> and 12<sup>th</sup> and the non-public minutes from December 29<sup>th</sup>. J. Stuart seconded the motion and all were in favor.

**Manifest Approval:** C. Iocovozzi moved to approve manifests for \$14,697.62 dated 12/30/14, \$192,017.60 dated 1/6/15, \$182,465.91 dated 1/13/15, \$25,777.70 dated 1/20/15 and \$115,760.96 dated 1/27/15. J. Stuart seconded the motion and all were in favor.

**Orr & Reno:** C. Iocovozzi moved to add into the contract that the Town can cancel the contract at any time. Once this is added, the Chair is authorized to sign the contract. J. Stuart seconded the motion and all were in favor.

**HDC Budget:** C. Iocovozzi moved to amend the 2015 HDC budget to add \$3,000.00. This was completed to allow for a sign to be constructed in the HDC District dependent on approval of the Planning Board and Board of Selectmen. J. Stuart seconded the motion and all were in favor.
