FOOD RESOURCES

Meals on Wheels: Starting on April 2nd, meal delivery will be reduced to Mondays, Wednesdays and Fridays. There will not be meal delivery on Tuesdays and Thursdays. An extra meal will be included on Monday for Tuesday and on Wednesday for Thursday. Additionally, they will continue to deliver extra shelf-stable food and frozen meals, just in case. New customers are still being accepted, so please call 603-431-0561 to complete an application over the phone.

Back to Single-Use Plastic Bags -- Gov. Chris Sununu on Saturday ordered all grocery and retail stores to temporarily transition to the use of single-use paper or plastic bags only - no reusable customer bags -- due to the threat of the spread of the coronavirus. Customers' use of reusable bags is banned. The purpose of the order is to avoid the unintentional spread of the virus from home environments.

- All municipal buildings and facilities, schools and the Langdon Library remain closed to the public. Police, Fire and Town Hall are still staffed during regular work hours. Feel free to email or call.
- NH DMV has extended the expiration date for temporary motor vehicle plates and licenses.
 All temporary plates issued after March 1. 2020 are now valid through April 30, 2020. For information about how vehicle registration works in NH, click here. Town residents can renew their registrations online at www.newington.nh.us. State drivers' licenses and ID cards set to expire can be extended by phone for 6 months. Call 603-227-4020 to pay for and complete the extension.
- Town Board, Commission and Committee meetings have been postponed. Check the town website for virtual meeting schedules. They are in the process of being scheduled remotely.
- The IRS has announced that the deadline for filing Federal income taxes is now July 15, 2020.

GARBAGE COLLECTION/TRANSFER STATION

Trash pickup is on the normal schedule as is the Transfer Station although the Swap Shop area
 needed to be cordoned off to avoid spread of the Covid-19 virus.

PARKS

Fox Point and the Federal Wildlife Reserve are great places to walk but are not designated offleash for dogs. NH State Parks and trails including the Little Harbor Loop Trail are also open.

NH Employment Security (NHES)

- Filing for unemployment. You are assigned a day and time to file based on the first letter of your last name. The unemployment system hotline is 603-271-7700.
- Payments are made beginning eight days from when the claim is filed. Those filing claims
 must log in again for each week of continued eligibility and file a continued claim.
- If you're Self Employed and have filed for unemployment benefits, ignore the Denial Message
 you receive. Your unemployment claim requires time to process as a result of your being Self
 Employed. You will receive a telephone call from NHES to obtain wage information to process
 and complete your unemployment claim.

QUARANTINED?

• Tell first responders if anyone in your household is quarantined due to COVID-19 and if you need contact with the Fire Department, Police Department or other emergency services. If they are not wearing personal protective equipment when they were exposed, they must self-quarantine for 14 days. No exceptions. That reduces the force available to respond to emergencies.

• Remember to wipe down your cell phones when you're sanitizing surfaces. They're in constant use, connecting hands and face.

Spring Yard Cleanup Safety Tips

Blue skies, chirping birds, warming temperatures — April is prime time for getting home exteriors, yards, and gardens back into shape. But before you get started on your outdoor to-do list, make sure you take appropriate safety precautions.

Dress for the job

• Wear shoes or boots, not sandals, to protect your toes.

- Properly fitting gloves can not only improve your grip on tools but also help keep skin safe from blisters, sunburn, bug bites, poisonous plants, and chemicals.
- Hearing protection is a must-have when using loud equipment.
- Safety glasses keep flying objects out of your eyes.
- Bug spray keeps the pests away. Shower after use to remove the chemicals from your skin. And while you're at it, take a minute to look for ticks. If you find one, gently pull it out with tweezers.
- Apply SPF to any exposed skin. Don't be fooled by cloudy days; you can still get a sunburn.

Work smart

- Take time to stretch and warm up before the work begins. Weeding, trimming, and raking are repetitive motions change your posture or stance every few minutes and switch activities every 30 minutes.
- Lift properly by bending at the knees and hips and using leg power rather than bending at the waist and putting the strain on your back. Instead of carrying heavy or unwieldy loads, employ a cart or wheelbarrow.
- Drink water and take breaks in the shade. Even if it's not hot or humid, yard work is exercise, and staying hydrated is important to avoid heat-related illness.
- Don't drink and drive. Don't text and drive. The same rules that apply to vehicles apply to
 power tools, including lawn mowers. Say no to distractions and anything that might cloud
 judgment.

Ready the tools

- Familiarize yourself with power tools and how they work. Read owner's manuals (many are available online) and know about various switches, modes, and required maintenance.
- Check cords on tools and extension cords for cuts, cracks, and frayed wires and do not use them if damaged. Also check the label to make sure you don't use an indoor extension cord outside.
- Make sure tools are in the "off" position before plugging them in or unplugging.
- Use ladders safely: Set on a firm, level surface; never stand on one of the top three rungs; and use a utility belt to hold tools so you can properly climb facing the ladder.
- Call 811 before you dig. This notifies local utilities to check your property before you plant a tree, dig a trench, or set fence posts.

Protect loved ones

• Be sure children and pets are inside (or well supervised if out) while you work.

- Store sharp tools, weed killer, fertilizer, and other dangerous items in a locked cabinet out of reach of curious hands and mouths.
- Before allowing any child to operate a mower, sound judgment, strength, coordination, and
 maturity are necessary. The American Academy of Pediatrics recommends that children
 should have these characteristics and be at least 12 years old before operating any type of
 mower and at least 16 years old to operate a riding mower. Be sure to educate and
 supervise kids as they learn how to safely use the equipment.
