My name is Nicholas Burns. I've grown up in New Hampshire most of my life. I graduated from Fall Mountain Regional High School in Langdon, NH and continued my education at Plymouth State University in Plymouth, NH. After graduating, I began my law enforcement career at the Sullivan County Department of Corrections in Unity, NH. #### Fire Department Promotions and Swearing In Ceremony Scheduled

The Board of Fire Engineers is pleased to announce the appointment of Lt. Patrick Moynihan to the position of Assistant Fire Chief for the Newington Fire Department effective January 13, 2020.

### **GENERATOR SAFETY**

When using portable generators please, for the safety of you, your family and pets follow these guidelines:



• Use portable generators outdoors in well-ventilated areas at least 5' away from all doors, windows and vents.

- Make sure you have working carbon monoxide alarms in your home.
- Do not use a generator in a wet area. This can cause shock or electrocution.
- Turn off generators and let them cool down before refueling. Never refuel a generator while it is hot.
- Store fuel in a container that is intended for the purpose and is correctly labeled as being for fuel. These containers should be stored outdoors.

#### **Electric Portable Space Heater Safety**

When the weather turns cold, it can bring a chill into our homes. Portable space heaters have become a popular way to supplement central heating or to heat one room. If you plan to use portable electric space heaters, make sure to follow these tips and recommendations.



- Purchase a heater with the seal of a qualified testing laboratory.
- Keep the heater at least 3 feet away from anything that can burn, including people.
- Choose a heater with a thermostat and overheat protection.
- Place the heater on a solid, flat surface.
- Make sure your heater has an auto shut-off to turn the heater off should it tip over.
- Keep space heaters out of the way of foot traffic. Never block an exit.
- Plug the heater directly into the wall outlet. Never use an extension cord.
- Space heaters should be turned off and unplugged when you leave the room or go to bed.

#### Tax Exemptions and Tax Credits

The Newington voters over the years have recognized the importance of assisting our elderly and disabled residents with property tax exemptions and have honored our Veteran's with a generous Veteran's credit. The Legislature added a new optional credit for the town's to consider adopting for Veteran's. The cost of the exemptions and tax credits that are granted to qualified property owners is shared by all of the other property tax payers, which is why any changes to the States minimum requirements must be voted on at Town Meeting. Many of our property owners enjoy the benefits of these credits and exemptions while there may be other residents that are not aware of the options that are available to them. A tax credit is an amount of money that is deducted directly from the taxpayer's tax bill, and a tax exemption is the amount of money that is deducted from the assessed valuation of the real estate before the property tax is billed. The State of New Hampshire requires municipalities to provide these benefits, with the town having the option to set the limits and establish requirements that are more favorable than the State's minimums and offer additional exemptions that are not required.

#### VETERANS TAX CREDIT

The State of New Hampshire, through RSA 72:28 requires towns to provide a minimum tax credit to qualifying veterans of \$50 with the option for Town Meeting to increase that up to \$750. Newington residents voted to increase the Veteran's Credit to the maximum of \$750 in 2019. The requirements to qualify for a Veterans Credit are set by the State and require that the property must be the principle residence of the Veteran and the Veteran must have lived in New Hampshire for one year preceding the April 1<sup>st</sup> that the credit begins. The Veteran must have also served in a specific qualifying war or armed conflict for not less than 90 days and have been honorably discharged.

In 2016, the State Legislature added an Optional Veteran's Credit that towns may adopt that will extend the Veteran's Credit to all Honorably Discharged Veteran's with 90 days of active service, regardless if they served during one of the armed conflicts previously required. The Board of Selectmen has placed that optional credit on the ballot for approval by the voters in March. There have been several Newington Veterans that have not qualified for a credit that will now become eligible. If approved, the deadline to apply for this new credit for the 2020 tax year will be April 15, 2020. #### **ELDERLY EXEMPTIONS**

All municipalities in New Hampshire are required to offer a tax exemption for elderly residents that are 65 years of age or older and have lived in New Hampshire for the three prior consecutive years. There are minimum financial requirements that are set by the State, and town's then have the ability to adjust those requirements through Town Meeting votes. The property must be owned by the resident, jointly with a spouse, or in trust with the qualifying person shown as a trustee to qualify. If the property is owned jointly with someone other than a spouse that does not meet the age requirement, the exemption is prorated based on the percentage of ownership. Currently the financial requirements are that the tax payer must have a net income of not more than \$40,000 if single or \$60,000 if married; and own assets not in excess of \$500,000 excluding the value of the person's residence. The exemption amount for residents that qualify between the ages of 65 and 74 is \$200,000; for residents between 75 – 79 the exemption amount is \$300,000 and for residents age 80 and over the exemption amount is \$300,000. The net income is defined as all moneys received from any source, including social security and pensions, and then deducting proceeds from the sale of assets such as stocks. If the property is a duplex, the rental income is counted. The town is required to certify that residents receiving the elderly exemption continue to qualify and that is done periodically.
