Planning Board

At Town Meeting, the voters of Newington will be voting on four (4) Articles which would amend the Zoning Ordinance in several ways, from modifying the review process for ground-mounted solar arrays to streamlining certain wetland permits to modifying the Historic District at Bloody Point.

This Article will focus on Article 5 (Zoning Amendment #4) which would change the permitted uses in the Bloody Point Historic District from Residential to Office uses. The current District has been in place for decades, although there's a strong likelihood that it was too small (part of a single lot) to meet the standards for the creation of a zoning district, rendering it unlawful.

The legal definition of Spot Zoning is:

The granting to a particular parcel of land a classification concerning its use that differs from the *classification* of other land in the immediate area.

Spot zoning is *invalid* because it amounts to an arbitrary, capricious and unreasonable treatment of a limited area within a particular district and is, therefore, a deviation from the master plan.

The Bloody Point Historic Zoning District was never a significant concern to the Town or the Planning Board, as the property has been owned by the State of New Hampshire for over 50 years and unused during this period of time. However, the State of New Hampshire announced in 2021 that the property was going to be sold, and while the State offered it to the Town (with many conditions and financial obligations) the Board of Selectmen unanimously decided against pursuing the acquisition of the former railroad depot.

The sale of the property caused the Planning Board to study the situation and examine the current uses allowed in the district. This district is approximately two acres in size upon which sits the former railroad depot and is residentially zoned. All of the property surrounding this two-acre area is zoned Industrial or Office, and after careful consideration, requests for input from the Historic District Commission, the public at-large, and after multiple public meetings and a Public Hearing, the Board voted to advance Article to Town Meeting 2022.

Why is this Amendment important? Why now? What affect will it have, and will it preclude the property from being used at it was in the past? The State of New Hampshire has begun the process to sell this property; the time to correct the Zoning District and permit uses allowed in the immediate

surroundings is now. The Planning Board considered waiting another year to allow for further study, but determined that any potential purchaser of the property should know how the property is zoned in advance of the sale. Finally, this property was never built or intended to be used as a single family-residence, rather, it has always been a railroad depot with a caretaker's residence attached. The current Newington Zoning Ordinance *allows* for a caretaker's residence as part of a commercial business, so the historic use of this property may continue as a business with or without a caretaker's residence. The Town of Newington has written and adopted many Master Plans over the decades, most recently adopting a Master Plan in 2020 which have all stressed the importance of separating different land uses geographically, which is how Newington has developed and preserved our residential areas while allowing a myriad of uses from heavy manufacturing to offices to retail well-separated from our residential zones.

The Planning Board works tirelessly to plan for today and tomorrow, and this Amendment was not placed on the 2022 Town Meeting Warrant without very careful consideration and study – we would appreciate your support of this, and the other zoning amendments at Town Meeting.

Newington Fire & Rescue

Although March is here and spring is right around the corner, February proved that winter is not quite ready to loosen its grip just yet. As it starts to warm back up during the day, remember to watch for icing from the melting snow during the overnight hours on walkways and roadways.

We recently found out the Department was awarded a GOFERR grant from the state to upgrade our existing Ambulance power cot to a new power loader system. The grant request was for nearly \$32,000 for the equipment and installation. This equipment will be able to dramatically reduce the potential for back injuries while loading patients into the ambulance.

While on the topic of good news, the new command truck that was ordered last March has finally been delivered and is currently being outfitted at New England Vehicle Outfitters (NEVO) here in Town. It should be going into service in the very near future.

As March is the time for Town elections (3/8) and Town meeting (3/12), if you should have any questions, looking for clarification or would like to discuss any part of the FD budget or warrants, please feel free to reach out to me at the contacts below or swing by the station.

Don't forget on March 13th to "spring ahead" with your clocks. Please make sure to check your smoke and CO alarms as well to make sure the batteries are fresh and in proper working condition. Should you need any assistance with your alarms please let us know.

Change Your Clocks / Check Your Smoke & CO Detector Batteries

When it's time to "spring forward" or "fall back" and change your clocks, make sure to change the batteries in all of your smoke alarms. If batteries were recently changed, it's still very important to conduct your monthly test of your smoke alarms. It could save a life!



Did you know that having a working smoke alarm reduces a person's chance of dying in a fire by half?

For the best protection, install smoke alarms on every level of your home, outside every sleeping area, and in every bedroom. Smoke alarms should be mounted high on walls or ceilings and tested monthly. You should also have a properly working Carbon Monoxide detector on each level of your home.



It's important to replace smoke alarm batteries at least once a year, unless they're 10-year lithium batteries. Even if your smoke alarms are hardwired, replace the batteries in case of a chirping sound or a power outage.

Reminder: Smoke alarms do not last forever. The maximum life span is 10 years. After that time, the entire unit should be replaced. If the unit does not respond

properly when tested, it should be replaced immediately.

Help your smoke alarm remain sensitive and ready to protect you by gently using a vacuum cleaner once a month to remove dust and cobwebs. If your Smoke Alarms have been accidently painted or contaminated, replacement may be necessary.
